

**ETORO X 0.1 ETH WALLET PROMOTION
TERMS AND CONDITIONS**

PLEASE NOTE: IT IS YOUR SOLE RESPONSIBILITY TO REVIEW AND UNDERSTAND YOUR ELIGIBILITY TO PARTICIPATE IN OUR PROMOTIONS. Promotion Description:

This is a promotion (the "**Promotion**") under which, during the Promotion Period (as defined below), each Eligible Participant (as defined below) will receive from us a sum of 0.1 ETH (one tenth of Ethereum) (the "**Gift**"), subject to all terms herein and as will be determined by eToro.

This Promotion may be limited to certain countries under our sole discretion, and any user wishing to participate in the Promotion must be a resident of such countries.

What are the start and end dates?

This Promotion starts at 10:00 GMT on November 5, 2018 and ends at 23:59 GMT September 30, 2019 (the "**Promotion Period**"). At eToro's sole discretion, the Promotion may be terminated at any time prior to the expiration of the Promotion Period, or it may be extended following the lapse of the Promotion Period.

This Promotion shall apply to the first 100,000 (one hundred thousand) users that shall download eToro Wallet Application (the "**Wallet application**") and shall meet all the terms set forth below with respect to becoming Eligible Participants. Any user downloading the Wallet that shall not be included in the first 100,000 Eligible Participants shall not be eligible to participate in the Promotion and/or receive the Gift.

Can I Enter?

I. Any user that: (a) shall download the Wallet, and (b) meets all of the following cumulative requirements, and (c) is one of the first 100,000 users meeting such cumulative requirements, shall be considered an Eligible Participant. To become an Eligible Participant, the user has to comply with all the following:

- (a) Complete the registration process set forth below:
 - (i) Download the eToro Application from the application stores;
 - (ii) Complete the registration process applicable to the users of eToro Application;
 - (iii) Complete the user profile and the verification process pursuant to eToro's procedures and policies (including uploading the required documents);

- (iv) Sign in to the Wallet using such user's eToro credentials;
- (v) Click '+' to create Wallet;
- (vi) Click "Add" next to the Ethereum Wallet;
- (b) Be at least 18 years old, or the age of legal consent for engaging in financial investment activities under the laws of any jurisdiction that applies to the user;
- (c) Not be an employee of eToro or of an eToro affiliate and NOT be an immediate family (parent, sibling, spouse, child) or household member of an eToro employee, an employee of an eToro affiliate, or a person involved in any part of the administration and execution of this Promotion; and
- (d) Not be involved in any part of the administration and execution of this Promotion.

II. The Gift shall be given to the first 100,000 Eligible Participants subject to the terms of this Promotion.

The Promotion is personal and non-transferable and shall apply solely to users opening a Wallet during the Promotion Period and meeting all the terms set forth herein.

At any given time, starting from the date of your registration with us, we may ask you to provide personally identifiable information. eToro reserves the right to limit, block access to its services and/or terminating the user account if such information is not provided. If you choose to provide us with the information and register with us as our customer, you are confirming to us that any information provided is true, accurate, updated and complete information about yourself.

You may not exchange or withdraw your Gift for cash. You may not designate someone else as the receiver of the Gift.

The use of eToro Services in general and the Wallet in particular may be subject to certain fees and commissions. You will be required to pay all applicable fees payable to eToro. Furthermore, your acceptance of the Gift may result in tax consequences. You will be solely responsible for all of the tax related payments including country, federal, state and local taxes if applicable.

If you attempt to compromise the integrity or the legitimate operation of this Promotion by hacking or by cheating or committing fraud or manipulation in ANY way, including by providing false details or by false registration, we may seek damages from you to the fullest extent permitted by law. Further, we may not provide the Gift and/or deduct the sum of the Gift that was given to you under this Promotion and/or ban you from participating in any of our future Promotion, so please act fairly.
- e. Eligibility to participate in this Promotion is limited to one Wallet per person/household or environment in which computers are shared. Users participating who have more than one trading account will only be eligible for the Gift once.
