

## **ETORO X XRP WALLET PROMOTION TERMS AND CONDITIONS**

### **Promotion Description:**

This is a promotion (the "**Promotion**") under which, during the Promotion Period (as defined below), up to 25,000 Eligible Participants (as defined below) can open an XRP wallet with eToro X Limited (the "**XRP Wallet**") free of the following charges: (a) XRP wallet creation fees (at the rate of 45 XRPs, the "**Reserve**"); and (b) eToro's XRP coin transfer fee by executing XRP coin transfer, subject to all terms herein. Any user opening the XRP Wallet that shall not be included in the first 25,000 Eligible Participants shall not be eligible to participate in the Promotion and/or receive any benefit thereunder. Blockchain fees apply when sending and receiving cryptoassets. Please note that the Reserve must be held as a minimum reserve in the address and cannot be sent to other addresses (<https://developers.ripple.com/reserves.html>).

This Promotion may be limited to certain countries under our sole discretion, and any user wishing to participate in the Promotion must be a resident of such countries.

### ***What are the start and end dates?***

This Promotion starts at 15:00 GMT on December 25, 2018 and ends at 23:59 GMT on December 31, 2019 (the "**Promotion Period**"). At eToro's sole discretion, the Promotion may be terminated at any time prior to the expiration of the Promotion Period, or it may be extended following the lapse of the Promotion Period.

### ***Can I Enter?***

**I. Any user that: (a) shall download the Wallet (subject to wallet availability in your country); (b) meets all of the following cumulative requirements; (c) eligible for XRP coin transfer pursuant to eToro's policy (currently fully verified, Gold club users and above and which have deposited using a wire transfer, up to the wire amount); and (d) is one of the first 25,000 users meeting such cumulative requirements, shall be considered an Eligible Participant. To become an Eligible Participant, the user has to comply with all the following:**

- (a) Complete the registration process set forth below:
  - (i) Be an existing eToro customer eligible for XRP coin transfer (see above);
  - (ii) Execute XRP coin transfer from the eToro web platform or mobile app of at least 133 XRP;
  - (iii) Download the eToro Wallet Application from the application stores if not installed already;
  - (iv) Sign in to the Wallet Application using such user's eToro credentials;
  - (v) XRP wallet will have been created automatically and XRP coin transferred from eToro
  
- (b) Not be an employee of eToro or of an eToro affiliate and NOT be an immediate family (parent, sibling, spouse, child) or household member of an eToro employee, an employee of an eToro affiliate, or a person involved in any part of the administration and execution of this Promotion; and

(c) Not be involved in any part of the administration and execution of this Promotion.

**II. The promotion shall be given to the first 25,000 Eligible Participants subject to the terms of this Promotion.**

The Promotion is personal and non-transferable and shall apply solely to users opening a Wallet during the Promotion Period and meeting all the terms set forth herein.

At any given time, starting from the date of your registration with us, we may ask you to provide personally identifiable information. eToro reserves the right to limit, block access to its services and/or terminating the user account if such information is not provided. If you choose to provide us with the information and register with us as our customer, you are confirming to us that any information provided is true, accurate, updated and complete information about yourself.

You may not exchange or withdraw your benefit under this Promotion for cash. You may not designate someone else as the receiver of the Promotion.

The use of eToro services in general and the Wallet in particular may be subject to certain fees and commissions. You will be required to pay all applicable fees payable to eToro. Furthermore, your acceptance of the Promotion may result in tax consequences.
