

## ETORO WALLET PROMOTION TERMS AND CONDITIONS

PLEASE NOTE: IT IS YOUR SOLE RESPONSIBILITY TO REVIEW AND UNDERSTAND YOUR ELIGIBILITY TO PARTICIPATE IN OUR PROMOTIONS. ### Promotion Description:

This is a promotion (the "**Promotion**") under which, during the Promotion Period (as defined below), each Eligible Participant (as defined below) will receive from us a sum of 0.1 ETH (one tenth of Ethereum) (the "**Gift**"), subject to all terms herein and as will be determined by ETOROX.

This Promotion may be limited to certain countries under our sole discretion, and any user wishing to participate in the Promotion must be a resident of countries that are supported by the eToro Wallet. A list of supported countries can be found at <https://www.etorox.com/wallet-faq/>

This list of supported countries may change periodically – please check the above FAQ link for the latest updates.

### ***What is the start and end date?***

This Promotion starts at 00:00 GMT on February 17th 2020 (and shall also apply to Gift received on February 16th according to the terms of this Promotion) and ends on May 10th 2020 (the "**Promotion Period**").

This Promotion shall apply to the first 10,000 (ten thousand) users that shall meet all the terms set forth below with respect to becoming Eligible Participants. Only the first 10,000 Eligible Participants shall be eligible to participate in the Promotion and/or receive the Gift.

You understand that your participation in any prior promotion(s) shall not in itself qualify you as Eligible Participant – this Promotion stands alone and ETOROX reserves the right to reject any user wishing to participate in the Promotion in accordance with these terms.

If you have received a 0.1 ETH Gift before you are not eligible to participate in this Promotion.

### ***Can I Enter?***

I. Any user that: (a) downloads the eToro Wallet Application from the application stores (the "**Wallet**" / "**Application**"), and (b) meets all of the following cumulative requirements, and (c) is one

**of the first 10,000 users meeting such cumulative requirements during the Promotion Period, shall be considered an Eligible Participant. To become an Eligible Participant, the user has to comply with all the following:**

- (a) Complete the registration process set forth below:
  - (i) Download the Wallet or, if you already downloaded the Wallet and completed steps ii– iv below prior to the commencement of the Promotion, continue with step v;
  - (ii) Complete the registration process applicable to the users of eToro Trading Platform;
  - (iii) Complete the user profile and the verification process pursuant to eToro's procedures and policies (including uploading the required documents);

  - (v) Click '+' to create Wallet;
  - (vi) Click "Add" next to the Ethereum Wallet;
- (b) Not activated the ETH Wallet in the eToro Wallet App prior to the commencement of the Promotion Period;
- (c) You have deposited a minimum amount of funds with the eToro's Trading Platform at least 10 days prior to your opening of the Ethereum Wallet. Minimum deposit depends on your region and country as further detailed in this link: <https://www.etoro.com/customer-service/deposit-faq/>;
- (d) Your eToro Trading Account must not be limited or restricted or under review for regulatory requirements;
- (e) Be at least 18 years old;
- (f) Not be an employee of ETOROX and NOT be an immediate family (parent, sibling, spouse, child) or household member of an ETOROX employee, or an employee of an ETOROX affiliate; and
- (g) Not be involved directly or indirectly in any part of the administration and execution of this Promotion.

ETOROX reserves the right to limit, block access to its services and/or terminating the user account if such information is not provided.
